- All registered candidates who wish to participate in round 3 off-line counseling must present themselves personally alongwith original documents before the Board on the designated place, date and time. To participate, print 'Entry Ticket' through candidate's login and carry the same.
- 4. Submission of original documents: All candidates who wish to participate in round 3 off-line counseling must bring* all the original documents and undertaking (as given in the instruction booklet available at the website) and accepted resignation from the institution he/she is pursuing studies at present (if any) or from the college allotted through any other counseling including All India PG counseling (if any). Failure to do so will result in disqualification for admission.

In round 3 off-line counseling, a candidate who gets fresh allotment shall deposit his/her original document alongwith undertaking and the requisite bond for Govt. Medical Colleges/RAJMES Colleges/RUHS CMS.

*Note: A candidate who joined a seat in Round 1 and retained or upgraded in 2 and joined or fresh allotted in round 2 and joined and is continuing on the joined seat is required to bring only Fee Receipt issued by the allotted institution while participating in round 3 off-line counseling. However, such a candidate will need to submit the requisite bond for Govt. colleges/RAJMES Colleges/RUHS CMS and complete other requisite formalities for Private colleges.

5. Resignation: Last date for submitting Resignation by the joined candidates of earlier rounds (round 1 and 2) at allotted college is 30.09.2023 by 5.00 pm (Exit with forfeiture of security amount). After this, resignation with forfeiture of security amount, shall be accepted only at the spot on candidate's merit-cum-roster point at the time of physical round 3 allotment.

No resignation will be accepted after passing over of candidate's merit-cum-roster point physical allotment (at the spot reporting).

After passing over of merit-cum-roster point of the candidate in round 3 allotment, no resignation shall be accepted even if the candidate gets the same seat (allotted in round 1 and 2) OR gets upgraded / allotted a fresh seat in round 3. It is clarified that no resignation will be accepted (from round 1, round 2 as well as round 3 allotted candidates) after passing over of the 'candidate's merit-cum-roster point'.

- 6. A candidate allotted a seat (fresh / upgraded) in round 3 of counseling and does not join the allotted seat, his/her security amount will be forfeited. Such candidate shall not be eligible to participate in further round.
- 7. The candidates are advised to visit the websites regularly for registration and other relevant information.
