In continuation to the earlier notifications, the stray vacancy round off-line allotment procedure for MD/MS, Post MBBS DNB and Post MBBS Diploma courses will be carried out as per the revised schedule given below:

Verification, Allotment and Reporting by Sr. Demonstrator candidates for In-Service Quota (sub quota), (before the Board, 10.00 am sharp at RUHS College of Dental Sciences, Jaipur) (after applying/registering as per the procedure) All such candidates must present themselves physically alongwith all original relevant documents, before the Board	18.10.2023, 10.00 am
Seat allotment Seat allotment on merit-cum-roster along with submission of all original documents before the Board at the venue - RUHS College of Dental Sciences (GDC), Subhash Nagar, Behind T.B. Hospital, Jaipur Candidates must present themselves physically for allotment on designated slot alongwith all original educational and eligibility documents Candidates who get allotment in Govt./ Rajmes medical college /RUHS CMS shall submit the requisite bond at the time of allotment.	18.10.2023, 10.00 am
Joining Joining, document checking and verification (including prescribed eligibility criteria) at the allotted college along with printout of allotment letter, deposition of one year tuition fee alongwith other fee/charges as prescribed by the college, required bonds etc. and other documents as listed in instruction booklet and also complete other formalities as mentioned on the website of the concerned institution	18.10.2023 to 20.10.2023 12.00 noon

1. Refer information booklet, college information sheet and college fee structure etc. and other information at the website. Regarding fee, also refer order dated 19.05.2022 of Hon'ble Supreme Court in civil appeal no. 3978-3995/2017.
2. All registered candidates who wish to participate in stray vacancy round off-line counseling must present themselves personally alongwith original documents before the Board on the designated place, date and time.
3. A candidate allotted a seat in stray vacancy round does not join the allotted seat shall be debarred from participating in the State counseling process for next one year, alongwith forfeiture of security amount.
4. No candidate will be allowed to resign from the State Quota seats after joining in round 3 or having status as 'Joined'.
5. **Submission of original documents:** All candidates who wish to participate in stray vacancy round off-line counseling must bring all the original documents and undertaking (as given in the instruction booklet available at the website).

In stray vacancy round off-line counseling, a candidate who gets allotment shall deposit his/her original document alongwith undertaking and the requisite bond for Govt. Medical Colleges/RAJMES Colleges/RUHS CMS.
6. **Eligibility**
 - Round 3 allotted / upgraded candidate is not eligible to participate in stray vacancy round.
 - A candidate who has already joined a seat allotted through Rajasthan state counselling / any other state counselling including all India counselling is not eligible to participate in stray vacancy round.
 - Candidates allotted a seat in All India stray vacancy round is not eligible to participate in stray vacancy round.
