Stray Vacancy Round Off-line Allotments-2023

In continuation to the earlier notifications, the stray vacancy round off-line allotment procedure for MD/MS, Post MBBS DNB and Post MBBS Diploma courses will be carried out as per schedule given below:

Schedule for Stray Vacancy Round Off-line Allotment process

<p><u>Application form (Registration)</u> Start date for filling of on-line application form and deposition of required application fee</p> <p>It is a mandatory step for subsequent process of counseling and allotment.</p> <p>Both the parts (Part 1 and Part 2) of the application form must be filled and completed.</p> <p>Candidates who could not complete both the parts (Part 1 and Part 2) of the application form earlier, may also complete the same.</p> <p>Those who are already registered/have applied need not register/apply again. However, their participation in Stray vacancy round shall be subject to their eligibility.</p> <p>Candidates who exited with forfeiture of security amount in Round 2 allotment and not registered earlier may apply again subject to their eligibility for participation in Stray vacancy round.</p>	11.10.2023

<p>Rs. 25,000/- for UR/EWS candidates or Rs. 12,500/- for SC/ST/ST-STA/OBC/MBC candidates opting for MD/MS course in Government Medical Colleges, Govt. Society Medical Colleges, RUHS CMS</p> <p>Rs. 2,00,000/- for candidate opting for MD/MS course in Private Medical colleges</p> <p>[Candidates depositing Rs. 2,00,000/- will automatically be eligible to fill choices for Government Medical Colleges, Govt. Society Medical Colleges, RUHS CMS]</p> <p>All candidates eligible to participate in stray vacancy round and willing, must deposit, if not deposited earlier, on-line INR 25,000/- (INR 12,500 for SC/ST/ST-STA/OBC/MBC) for allotment in Govt. Medical Colleges and Govt. Society Medical Colleges / RUHS CMS and INR 2,00,000/- (for allotment in Private Medical colleges) failing which they will not be considered for admission on a seat in a college in Stray vacancy round.</p> <p>All candidates who deposited security amount in earlier rounds and are eligible to participate in stray vacancy round are not required to deposit it again and who deposited only INR 25,000/- or 12,500/- as the case may be, and who now wish to opt for private colleges also (along with Govt. colleges) are required to deposit the difference amount of INR 1,75,000/- or INR 1,87,500/- (for private medical colleges) - (as the case may be) on-line, failing which they will not be considered for admission on a seat in a college.</p>

Hospital, Jaipur</p> <p>Refer date wise, time wise and merit wise slots list to be made available at the website</p> <p>Candidates must present themselves physically for allotment on designated slot alongwith all original educational and eligibility documents</p> <p>Candidates who get allotment in Govt./ Rajmes medical college /RUHS CMS shall submit the requisite bond at the time of allotment.</p>	<p>16.10.2023 to 17.10.2023</p>
<p>Joining</p> <p>Joining, document checking and verification (including prescribed eligibility criteria) at the allotted college along with printout of allotment letter, deposition of one year tuition fee alongwith other fee/charges as prescribed by the college, required bonds etc. and other documents as listed in instruction booklet and also complete other formalities as mentioned on the website of the concerned institution</p>	<p>16.10.2023 to 19.10.2023</p>

1. Refer information booklet, college information sheet and college fee structure etc. and other information at the website. Regarding fee, also refer order dated 19.05.2022 of Hon'ble Supreme Court in civil appeal no. 3978-3995/2017.
2. All registered candidates who wish to participate in stray vacancy round off-line counseling must present themselves personally alongwith original documents before the Board on the designated place, date and time.
3. A candidate allotted a seat in stray vacancy round does not join the allotted seat shall be debarred from participating in the State counseling process for next one year, alongwith forfeiture of security amount.
4. No candidate will be allowed to resign from the State Quota seats after joining in round 3 or having status as 'Joined'.
5. **Submission of original documents:** All candidates who wish to participate in stray vacancy round off-line counseling must bring all the original documents and undertaking (as given in the instruction booklet available at the website).
In stray vacancy round off-line counseling, a candidate who gets allotment shall deposit his/her original document alongwith undertaking and the requisite bond for Govt. Medical Colleges/RAJMES Colleges/RUHS CMS.
6. **Eligibility**
 - Round 3 allotted / upgraded candidate is not eligible to participate in stray vacancy round.
 - A candidate who has already joined a seat allotted through Rajasthan state counselling / any other state counselling including all India counselling is not eligible to participate in stray vacancy round.
 - Candidates allotted a seat in All India stray vacancy round is not eligible to participate in stray vacancy round.
